CONDITIONS FOR ENROLLMENT

1. The undersigned, his/her family and guests agree to abide by the rules and regulations set forth by the camp for the health, safety and welfare of all Campers.
2. I agree to pay my balance by June 1st, 2017. Further, I also agree that if I do not pay my balance in full by June 1st, the camp will automatically take payment from the credit card on file on June 2nd.
3. Due to the fact that all camping programs are planned prior to the opening of camp, including purchasing camper supplies, equipment, and hiring of personnel based on confirmed camper reservations, final payment for River Way Family Camp is due June 1st and our cancellation policy is as follows: no allowances, refunds, or rebates can or will be made for cancellations occurring after April 15th, 2017.
4. The Camp reserves the right to dismiss a Camper whose conduct or influence is unsatisfactory, or, in the opinion of the Camp Director, not in the best interest of the Camp and, in that event, there shall be no refund of any part of the tuition.
5. The Camp is not responsible for articles of clothing or personal belongings lost or damaged by fire, theft or laundering.
6. In case of medical or surgical emergency, we hereby give permission to the physician selected by the Camp Director to hospitalize and secure proper treatment for any member of our family. All such expenses will be the responsibility of, and shall be paid by, the individual.
7. We agree to complete and submit a health form for all minors due no later than August 1st, 2017.
8. The undersigned consents to the use of any pictures, addresses, and phone numbers of family members for the purpose of Camp Rosters, advertising or promotions.
9. I/We understand and acknowledge that certain activities provided by the Camp (including, but not limited to, horseback riding, waterskiing, sports, ropes course, etc.) have an increased risk of injury. I/We further acknowledge and state that I/We will assume full responsibility for my/our family's safety and hereby agree to release and indemnify Western Camps, Inc., River Way Family Camp, and all of their officers, employees, agents and representatives whatsoever, from any claims, cost, expense, including attorney's fees and or damages which any of them may incur arising from our Family's participation in such activities.

I/We, the undersigned parents or guardians of minor Campers listed on the reverse side agree that I/We are solely responsible for the supervision and safety of our children at all times during their attendance at Family Camp, except during those times when these children are participating, with prior approval, in a supervised activity offered by Western Camps, Inc.
